As you know and the Forest Service acknowledge the "solution" to the Esparanza access has been a disaster. Not only the near \$1,000,000 the Forest Service has spent on it (with more to come) but the decisions made by the Forest Service has continued to cause more and more problems and endanger more lives. The latest fiasco is the \$800,000 worth of rock recently laid down has caused upwards of 80 flat tires to date including those on service vehicles.

To reiterate; the additional endangerment to human life of increased response times, added milage, reduction of emergency evacuation routes etc is inexcusable and your reasoning unsupported. Your response has been the closure has to be maintained because it "exposes the public to risk to life". I recently visited Paradise Ca to visit friends. The devastation was enormous. As you know it was one of the deadliest fires in US history. I as said earlier Cal Fire still has not provided the Pilgrim Creek area users with valid evacuation routes.
